OUR GOAL IS TO PROVIDE A FUN AND SUPPORTIVE ENVIRONMENT THAT FACILITATES YOUR TRAINING GOALS.

HOW THINGS WILL RUN:

We will group dogs by jump height and you will be allowed to combine your 90 second runs together if you want.

If you have several dogs of different jump heights, we will allow you to run your dogs in one time slot.

The Pre-Agility Ring: We will have one ring set up with jump bumps, various conditioning and balance cushions and other objects for those who wish to expose their dogs and puppies to a pre-agility environment in a new setting.

The Agility Ring: We will have a nested course that includes all contacts but will be set up so that you can run a Jumpers course if you wish. There will be a set of 6 and also a set of 12 weave poles so you can choose which set you want to use.

Of course – your time in the ring may be used any way you want. We can assist you with special help such as being in the ring as a “judge”, baiting target plates, filming your runs on your phone or iPad, etc.
